SALES CONTRACT

All puppies are guaranteed free of all infectious diseases for a period of two weeks from the date of purchase. In addition, all puppies must be seen by your veterinarian within 72 hours of purchase. Congenital or genetic defects that appear in the pup prior to 18 months of age and that prevent the animal from enjoying life as a companion dog are also covered by this guarantee. Veterinary proof of such condition must be provided, as well as examination of the animal(s) by the breeder's veterinarian, (at breeder's election). If it has been satisfactorily determined that the owner has reared the pup properly – providing a correct diet, proper exercise and veterinary care, as well as appropriate living conditions, pups will be replaced with an animal of the same sex and quality from the first available litter. The breeder bears no responsibility for any medical costs in excess of the purchase price of the puppy. This guarantee is null and void when there is evidence of improper care by the owner. The purchaser agrees to follow the dietary plans/exercise programs/veterinary schedules/training and living conditions suggested by the breeder.

SHOW PROSPECTS

Show prospects are guaranteed to be free of any physical defect or major deviation from the breed standard that would disqualify it from the show ring at the time of purchase. They are also guaranteed to be sound breeding stock at the time of purchase. They are not guaranteed to finish a championship. Replacement of show prospect animals will follow the same procedure as above; however, the animal to be replaced is subject to resale as a companion dog by the breeder. Alternatively, the animal may be retained by the owner, spayed or neutered, and the differential between a companion and a show prospect at the time of purchase will be credited toward the replacement dog. All show/breeding dogs will remain co-owned by Breeder for the duration of their lives. Any and all breeding prospects will be approved by breeder after appropriate health testing results have been reviewed for both Sire and Dam. We reserve breeding rights to all show quality males for bitches owned, co-owned or leased by Manoka's Honeybee.

Should you purchase a show prospect and decide not to show it, Manoka's may request, and will be permitted, the ability to show your puppy at times convenient to both parties for days and/or overnight weekends. Owners will be responsible to present the puppy bathed with nails trimmed, <u>no further trimming at all</u> should be done, and provide enough food to sustain puppy the days he/she is being shown. Manoka's will be responsible to all entry fees and travel expenses for the time puppy is being shown.

COMPANION DOGS

Companion dogs are sold with an AKC Limited Registration, and are not to be bred or shown in a conformation ring. They may be compete in Obedience Trials, CGC, etc. It is required that all companion dogs will be neutered/spayed at an appropriate time, to be decided between breeder and owner, always in the best interest of the health of the dog. AKC Registration for all dogs will remain in the name of the breeder and owners until such time as spay or neuter has been completed, after which, breeder will remove herself from AKC registration. If for any reason the purchaser cannot keep the dog, *the breeder will make*_

<u>every effort to locate a placement in a new home OR take the dog back.</u> At no time is the <u>dog to</u> be <u>turned over to a shelter or rescue.</u> There <u>will be no refund of the purchase price.</u>

Puppy deposits once accepted, are <u>not refundable</u> unless a <u>puppy of the</u> desired sex or quality cannot be provided. Puppy prices remain the same from 8 weeks up to one year of age. Thereafter, prices are adjusted according to the age/condition of the dog.
